Dear Golf Outing Coordinator;

Welcome to the 2010 golf season and thank you for selecting **BRAE BURN GOLF CLUB** and its facilities for your golf event.

Our golf and cart fees for the 2010 golf season are as follows:

## **WEEKENDS AND HOLIDAYS**

18 Holes with cart.....\$ **48.00 each**

## **WEEKDAYS**

18 Holes with cart.....\$ **38.00 each**

### **BRAE BURN GOLF CLUB IS A SOFT SPIKE ONLY FACILITY!**

Power carts are mandatory for all groups that reserve tee times in advance. This policy would include weekdays, weekends and holidays.

*In order to assure that your outing is organized and run efficiently, we will require the following from your group's coordinator.*

\* A deposit of minimum \$200.00 to assure your date and tee times (Based on a minimum of 12 players). All deposits must be received no later than 14 days after booking your outing date. If a date is booked within the 60-day period prior to the outing date, the group must send the required deposit within 7 days of the initial contact.

\* All groups will be held responsible for the number of players at least 14 days prior to the event. Please keep Brae Burn management informed if the number of players is modified.

\* **A guaranteed number of players no later than 2 weeks (14 days) prior to the date of the event. Group coordinators should be advised to set-up a deadline for payment from the players in the outing. Prepayment of outing players will insure a well organized event. The group will be held responsible and will be billed for 100% of the figure called in during the initial contact, unless it is changed prior to the 14-day deadline. The same policy applies for the number of food orders.**

\* On or before the day of the event the golf course will require a list of players, according to tee time, along with complete payment (One check, Cash, MasterCard, Visa or American Express) for golf, carts and dinner if eating afterwards. **One lump sum for all golfers, less deposit, must be paid prior to the first tee time!**

It is against the *STATE OF MICHIGAN LIQUOR CONTROL COMMISSION* laws to bring and consume your own alcoholic beverages on these premises. Alcoholic beverages, which are not purchased from BRAE BURN GOLF CLUB, are not permitted on the premises. Also, coolers of any kind will not be allowed on the golf course, under any circumstances. Excessive drinking leads to slow play, disruptive behavior and destruction to the carts and grounds. Your cooperation in this matter is greatly appreciated.
